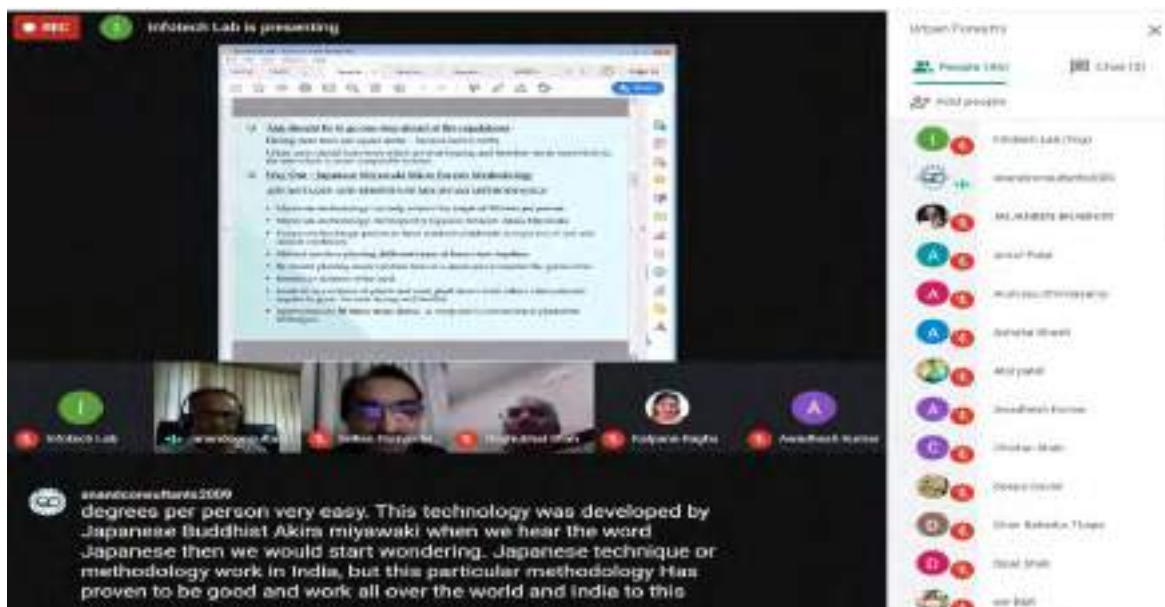

He further discussed about the cost and benefits Miyawaki Methodology. He also cited few case studies that have adopted the Miyawaki Micro forests Methodology.

Dr. Deepa Gavali, Acting Director at Gujarat Ecology Society made a presentation on “Urban Forests: Pollution Mitigation & Ecosystem Services”. She explained in detail about the different aspects of ecosystem services such as provisional services, regulating services, cultural services and supporting services along with examples.
